## EMPLOYMENT AGREEMENT

In consideration of the covenants and agreements herein contained and the moneys to be paid hereunder WECURO, INC., hereby employs the EMPLOYEE, and the EMPLOYEE hereby agrees to perform services as an employee of WECURO, INC., on an "At Will" basis, upon the following terms and conditions:

# 1. Appointment

The employee agrees to abide and be bound by the restriction and prohibitions of this Article as an independent contractor, partner or joint *venturer*, or as an officer, director, stockholder, agent, employee or salesman for any person, firm, partnership, corporation or other entity, or otherwise.

### 8. Confidentiality

EMPLOYEE will not at any time, directly or indirectly, disclose any Confidential Information, in full or in part, in written or other form, to any person, firm, corporation, association or other entity, or utilize the same for any reason or purpose whatsoever other than for the benefit of and pursuant to authorization granted by the WECURO, INC.

### 9. Non-Competition with WECURO, INC Clients

Employee agrees that during the term of the Employee's employment with the WECURO, INC, and for a period of year following the cessation of the relationship with the WECURO, INC., the Employee shall not provide any service to or lend any aid to any of clients of the WECURO, INC.
